

Report of the Committee on Lectureships for the Year ending June 30, 2013

It is my pleasure to report that the Sigma Xi Lectureship Program continues to be one of our Society's most successful endeavors. It provides outstanding lecturers to chapters and their host institutions, while offering an opportunity for outreach to the broader community interested in science. This is a report of the activities of the Committee on Lectureships from July 1, 2012 – June 30, 2013.

I. THE SIGMA XI DISTINGUISHED LECTURERS

The Committee selected 22 speakers to serve as the 2012-2013 Distinguished Lecturers. These speakers addressed subjects and issues including science, mathematics, engineering, medicine, science philosophy and education. The Committee is pleased to announce that, in addition to the lecturers selected by the committee, the American Meteorological Society, the National Academy of Engineering, the National Cancer Institute, sponsored speakers for the series. These organizations provided funding to subsidize Sigma Xi chapters as they engage lecturers at local events.

The list of Distinguished Lecturers, along with their brief biographies and information about lectures on offer, was included in the January-February 2012 issue of *American Scientist*. The Lectureship Committee is keenly aware of the need to achieve a balanced class of lecturers in terms of discipline, geography, gender and ethnic plurality. These criteria inform our primary responsibility to offer, as lecturers, outstanding research scientists and engineers who deliver stimulating and effective lectures to a broad audience representing a wide range of disciplines.

In 2013, the honorarium offered to Distinguished Lecturers was increased to \$300. Chapters pay this modest honorarium, in addition to travel and subsistence, when hosting a Lecturer.

II. LECTURESHIP SUBSIDY PROGRAM

Sigma Xi continues to provide modest subsidies for chapters to participate in the Distinguished Lectureship Program. Since the allocation of subsidy funds available is not adequate to meet demand, the Lectureship Committee gives priority to those chapters that demonstrate the greatest need for, and potential to benefit from, Sigma Xi support. For fiscal year 2013, a total of \$22,770.00 was awarded to the following 29 chapters:
