SIGMA XI, THE SCIENTIFIC RESEARCH SOCIETY Report of the Committee on Grants-in-Aid of Research For the Year Ending 30 June 2017

The Sigma Xi Grants-in-Aid of Research Program is now in its ninety-fifth year. The Committee on Grantsin-Aid of Research held two meetings during fiscal year 2017. During the meetings, the Committee reviewed a total of 1,549 applications, of which 265 (17%) received full or partial funding. A total of \$211,559 was awarded. This represents a 9% decrease in the number of submitted applications from the prior year and a 9% increase in the number of applications funded. The committee attempts to stretch available resources to benefit as many students as possible.

The accompanying table shows the distribution of applications, awards, and funds among the science and engineering disciplines. The names of the recipients, their institutions, and project titles are listed on the Sigma Xi web site.

Support from members and interest income from the Society's research endowment continues to be an essential component of the GIAR program. Designated funds from the National Academy of Sciences, which are administered by Sigma Xi, provide valuable additional resources for the program and accounted for 50% of funds awarded. For the first time, \$800 in funding was awarded from the new Claude C. Barnett Grants-in-Aid of Research Endowment Fund during the Spring 2017 grant cycle. Barnett was a Sigma Xi member for 60 years and served as president of the Whitman College–Walla Walla University Chapter in Washington state. The award went to Carolyn Shasha, a doctoral student at the University of Washington who will use the funding to support her research project, "Investigating the Potential for Color MPI: Validating and Improving Simulations with Experiment."
